Q26214 for the fee AU \$990.00 (Two or more mares owned by the same person may be  
bred for an agreed fee by both stallion owner and mare owner.) subject to the following  
conditions.

1: **The Stallion Fee includes a \$250.00 non-refundable booking fee payable on the execution of this contract. All stud fees must be paid to O.H. Corral Enterprises on a 40-day pregnancy test. Invoices are payable on receipt. Breeding Certificate will not be issued until all monies due have been paid.**

2: The Stallion fee does not include veterinary charges, and or agistment etc for breeding the above mare. For a list of Agistment charges, or further information contact Pat or Liz O'Halloran on 07 49951214 or email [oh.corral@skymesh.com.au](mailto:oh.corral@skymesh.com.au).

3: This contract contains a "Live Foal Guarantee" (LFG). For this purpose a live foal is described as a newborn foal that stand and nurses without assistance. If the foal is born dead the mare will be eligible for a return service the following year.

4: Mare owners are responsible for all Veterinary and Agistment fees.

5: A Breeders Certificate will be issued for the foal conceived by this mating when the Stallion fee and all other expenses are paid in full and the mare has been pregnancy tested 40 days and pronounced safe in foal.

6: This contract represents the entire agreement between the two parties. No other agreements or promises, verbal or implied are included unless specifically stated in the written contract.

7. This contract is non-assignable and non-transferable. **Each party should individually initial additional conditions.**

**WHEN THE BREEDER AND MARE OWNER SIGN THIS CONTRACT IT WILL THEN BE BINDING ON BOTH PARTIES, SUBJECT TO THE ABOVE TEMS AND CONDITIONS.**
